Module Objectives

This module provides a detailed overview of the principles regarding the key aspects of Intellectual Property Law: International Copyright, Patents, Design Rights, Trademark and Passing Off and Misappropriation of Personality and Publicity and Privacy Rights. Case law illustrating the application of these principles along with international treaties dealing with Intellectual Property is addressed. The module seeks to enhance the learner's ability to apply theoretical aspects of the jurisprudence to real life situations through the use of case studies.

Module Aims (to provide learners with)

- the ability to solve complex Intellectual Property questions
- a political, philosophical and technical understanding of the fundamental principles of Intellectual Property Law
- a comprehension of the protection given to various works under Intellectual Property Law including secondary and neighbouring rights
- a knowledge of international conventions on Patents
- an understanding of the impact of the law of Tort on Intellectual Property disputes

Module Learning Environment

A learning environment that promotes collaborative learning is promoted and learners are encouraged to actively engage in all class discussions and exercises.

Module Teaching and Learning Strategy

The lecturer gives a brief presentation of the salient issues and then the learner is expected to contribute to the discussion format. For each week a different learner is assigned and expected to present a paper. Learners are given a week in advance the reading for the next seminar and are expected to have researched same in detail and be prepared to answer and field questions. There is a weekly guest lecture by an Intellectual Property Law practitioner.

Range of modes of direct contact

There are weekly lectures which adopt a Socratic method. Learners are expected to read in advance of each session and to participate actively. One learner is expected to lead the discussion for each individual lecture.

Independent Learning and Research guided by the lecturer and supported with many resources and tools through Moodle (to include podcasts, embedded videos, RSS links and discussion forums).

1	50	Continuous Assessment	4,000-5,000 word individual written essay. Oral presentation of topic to class, involving group debate and fielding questions. Learners engage with the key issues in copyright, trademark, patent, and passing-off law, with the aim that they develop a holistic picture of Intellectual Property Law and its latest developments and broader underlying debates. Of the 50% allocated to this CA, the written assignment is worth 40% while the oral presentation is worth 10%				
2	50	Examination	Closed book examination: a 3 hour exam which covers the breadth of the course and requires learners to answer 3 questions out of 6, testing their ability to apply knowledge learned throughout the module.
